# (a) To consider quotes for repairs to safety matting, and repairs to skateboard park area

Members considered quotes obtained for the repairs and agreed that Back2Front Landscaping Ltd should be instructed to complete the work.

### **RESOLVED:-**

Back2front Landscaping are appointed to conduct the repairs to the Skate Park and 2 areas of Play Area safety matting at a total cost of £700.00 (Excl VAT).

# (b) To receive an update on progress/quotes on the provision of fitness equipment

Members were provided with copies of quotes and brochures from suppliers for fitness equipment to be installed on the grass area near the entrance to the Skate Park. Three pieces of equipment were selected.

#### **RESOLVED:-**

That Sovereign Equipment are appointed to supply and install three pieces of fitness equipment, at a total cost of £1,831.44 (Excl VAT)

The Clerk was also asked to investigate the provision of further award signs for the main gate to display previous awards.

Renewal & rewiring of internal electrics at pavilion – further quotes to be obtained by the Club

Connection to newly installed electricity supply at edge of field – quotes to be obtained by the Club

Long term plans for provision of toilets / store – no detail as yet – for future consideration

Drainage of land near pavilion – the Clerk to assist by obtaining quotes for potential work and reporting as appropriate.
