

Minutes of the Annual Parish Council Meeting on 4th May 2022

22/FC5F North Somerset Council Matters

Councillor P Keating advised that the Home Office/Government had placed Asylum Seekers at the Holiday Inn near the airport. The hotel is isolated with no transport links. They are receiving a weekly allowance of £8 and all material needs are being met. The Surgery will arrange for healthcare staff to attend after hours if needed. Donations of footwear, clothes and simple board games, football/sports equipment and cakes would be greatly welcomed. Discussions are underway regarding providing transport with local companies. The Parish Council suggested using the playing fields to play football and councillor Keating will feedback to North Somerset of ways to make them feel welcomed.

Planning Applications:

21/P/2049/OUT Land to the east of Church Lane and north of Front Street, Churchill: This has gone to appeal. The PC (and Burrington) is engaged with the process.

22/P/0564/OUT (83 houses): Councillor Keating agrees this is unsuitable and has made this clear to the team. He will follow the process and call it in if needed. There is no update on Blagdon Water Gardens or Dinghurst Road application, Councillor Keating will follow this up and pass all correspondence regarding the Crest Nicholson parcel of land on Pudding Pie Lane to the enforcement team at NSC.

Local Plan:

This is now closed. He wished to thank those who contributed input to the (rather un user friendly) questionnaire. It will take a few weeks for the responses to be collated and reviewed, but he will share an update on the results as soon as they are available.

It is important to note that there is significant opposition to the allocations at Long Ashton, Nailsea and Portishead.

On the positive side NSC has reacquired the unused Homes England land in NSC which will have an important role to play in enabling urban focused developments. Banwell Bypass:

The second consultation has now closed. I responded highlighting the need for more measures in Churchill area and for Ladymead lane to be included in the scheme of mitigations. Councillor Ronicle updated the Council on data from the speed logging device used outside of Churchill Academy. The data showed that 64% of vehicles were speeding on Churchill Green. The device will be positioned around the parish for further data collection to present to North Somerset Council and the Police.

Special School:

DfE are yet to submit their planning application. He will be attending an update meeting with NSC education department on 10 May and will share details of where they currently stand.

In the meantime, he has undertaken to raise a question at the next Full Council Meeting on 10 May about the possibility of the community acquiring NSC land for a Jubilee Garden.

A38 Closure:

A reminder that the A38 will be closed at Redhill for 5 days from 23 May to support essential roadworks.

A38 MRN Scheme:

This had been paused in light of the airport appeal decision. He will be attending a meeting on Thursday for updates on latest status.

The Clerk advised there would be revised costs for the Beacon work for the Jubilee as the initial tentative grant application from the Village Fund for £300 based on estimates. The actual cost had increased to by a further £182.40. The Councillors agreed to the increase in principle and this would be added the agenda for June.

Councillor Jeacock advised that progress had been made regarding the Rule 6 status.

Councillor Wilkinson advised that the hedge needs cutting on the corner of Ladymead Lane. Councillor Bush will view and advise of what action is best suited. Councillor Ronicle advised that Pro Heating in Langford would consider siting a defibrillator outside their premises. The clerk will send a letter formally requesting

the positioning of a defibrillator.

Councillor Maycock has been in contact with Councillor Phil Neve at Wrington who has requested information from North Somerset regarding the Sports Centre. She is waiting to hear which other Parish Councils are interested in reopening of the Sports Centre.

Councillor Simpson advised that further strimming is needed under the trees and around the Hand area.

Councillor Baker advised that the installation of the bike racks has been postponed due to availability of a suitable location.

Councillor Croker will write a formal letter to the Masons to request funding for a defibrillator.

Councillor Murray remarked on how delightful the recent newsletter is and asked for old news to be removed from the website.

Councillor Bush advised that the manhole cover on the corner of Pudding Pie Lane and Broadoak had not been repaired by Highways. The Clerk will contact NSC.
